MINUTES OF ADJOURNED REGULAR MEETING – February 5, 2021

The adjourned regular meeting of the Board of Directors of the Irvine Ranch Water District (IRWD) was called to order at 12:00 p.m. by President Reinhart on February 5, 2021 via teleconference pursuant to the provisions of the Governor's Executive Orders N-25-20 and N-29-20 due to COVID-19. Members of the public did not attend this meeting in person.

Directors Present: Withers, Swan, McLaughlin, LaMar and Reinhart.

Directors Absent: None.

Also Present: General Manager Cook, Executive Director of Technical Services Burton, Executive Director of Water Policy Weghorst, Executive Director of Finance and Administration Clary, Director of Treasury and Risk Management Jacobson, Executive Director of Operations Chambers, Director of Recycling Operations Zepeda, Director of Information Services Malone, Director of Water Resources Sanchez, Director of Maintenance Mykitta, Government Relations Officer/Deputy General Counsel Compton, Secretary Bonkowski, General Counsel Collins, Consultant Brenda Deeley, and members of staff and the public.

SYPHON RESERVOIR IMPROVEMENT PROJECT UPDATE, BUDGET INCREASE, AND CONSULTANT SELECTION

General Manager Cook provided an introduction to the presentation regarding project, noting that staff analyzed the project to determine that it is cost effective, helps achieve IRWD's goals, and helps maintain IRWD's leadership position in the water industry in the future.

Principal Engineer Akiyoshi reported that since 2017, work has proceeded on several fronts analyzing the Syphon Reservoir project that resulted in updated information for the Syphon Reservoir Expansion Analysis. Mr. Akiyoshi reviewed the key evaluation components, introduced the seasonal storage alternatives, a Green Acres Project (GAP) expansion alternative, a financial analysis of both the Syphon Reservoir and GAP expansion projects, and reviewed impacts of seasonal storage on imported water purchases and groundwater pumping.

Executive Director of Water Policy Weghorst said that comments received during the CEQA NOP process led IRWD to conduct research and continue discussions with Orange County Water District (OCWD) executive staff regarding sending excess recycled water and receiving revenue from OCWD for sending excess recycled water through the GAP system. Scenarios included GWRS shortages, supplying GAP customers with IRWD recycled water, and water quality problems with OC SAN's secondary effluent. He said that multiple scenarios were explored, and reviewed the conclusions and observations with the Board.

Mr. Akiyoshi reviewed IRWD's goals and target activities' unquantified benefits, noting that the Syphon Reservoir made financial sense against the alternative of the GAP expansion as it would expand the use of recycled water while reducing the use of imported water for non-potable

purposes. The Syphon Reservoir could also become a source of water for IRWD's future potable reuse opportunities and provide other regional benefits.

General Manager Cook summarized the benefits of the Syphon project, noting that it is the most cost-effective option, increases IRWD's independence from imported water purchases, optimizes the use of recycled water for IRWD, and minimizes sewage to OC SAN and ocean discharges. He said that operationally it would be a beneficial use of recycled water, biosolids, and seasonal storage.

Senior Engineer Toland reported on the consultant selection and said that staff issued a request for proposal for engineering design services to AECOM, Black & Veatch, GEI, and Stantec. Mr. Toland said that staff received outstanding proposals, but AECOM's approach to completing the project exceeded those presented by the other firms. He said that AECOM outlined a focused and detailed work plan for completing the design services and presented innovative approaches to enhancing and improving project design concepts. He said that AECOM's proposed project management team has extensive experience working together, and both have managed previous projects for IRWD and other dam and reservoir projects. He further said that this management team recently delivered the design and construction of Santa Margarita Water District's Trampas Canyon Reservoir and Dam, which like Syphon Reservoir, is a 5,000-acre-foot recycled water storage reservoir.

IRWD's consultant, Mr. Brenda Deeley, provided a summary of the public outreach objectives and strategies. She said that over 40 presentations / briefings / notifications were held with members of the Irvine City Council, Irvine Unified School District, the Orange County Supervisor, state legislators, Congressional delegation, schools, homeowner associations, residents and many others.

Mr. Toland reviewed the CEQA highlights to date, a mitigation update and summary.

Director Withers reported that this item was reviewed by the Engineering and Operations Committee on December 8, 2020 and that he recommended moving forward with this project. Director Swan raised his concerns over this project, asked questions of staff, and said he would be voting no on this item. Following discussion, on MOTION by Withers, seconded by LaMar, and carried by the following roll call vote, LaMar, McLaughlin, Withers, and Reinhart voting aye, and Swan voting no (4-1 vote), THE BOARD AUTHORIZED A BUDGET INCREASE IN THE AMOUNT OF \$71,000,000, FROM \$75,000,000 TO \$146,000,000, APPROVED AN EXPENDITURE AUTHORIZATION IN THE AMOUNT OF \$139,650,000, AND AUTHORIZED THE GENERAL MANAGER TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT IN THE AMOUNT OF \$4,747,749 WITH AECOM FOR ENGINEERING DESIGN SERVICES FOR THE SYPHON RESERVOIR IMPROVEMENT, PROJECT 03808. It is to be noted that during the vote, Director McLaughlin had technical difficulties, but provided an affirmative vote using a hand signal of thumbs up. IRWD's legal counsel affirmed that this was an acceptable indication of an affirmative vote.

DRAFT IRWD 2021 GOALS AND TARGET ACTIVITIES

General Manager Cook reported that the foundational documents, the IRWD Mission, Vision and Values Statement and the IRWD Strategic Objectives are provided in the agenda package and asked if the Board wished to discuss or make recommendations for refining these documents. Following Director LaMar's comments, General Manager Cook said that he will

add an item to the Strategic Objectives relative to Climate Resiliency. Mr. Cook reviewed the 2021 Goals and Target Activities list and said that the changes were noted in a track change format. Following discussion on Item No. 3, "Optimize use of Irvine Lake as a water resource facility for IRWD and its current and future partners," Director Withers left the meeting at 2:56 p.m. Input from the Board was provided to staff for incorporation into the 2021 Goals and Target Activities list.

ACTION CALENDAR

ORACLE CUSTOMER CARE & BILLING UPGRADE

Director of Information Services Malone reported that IRWD's primary billing system, Oracle Customer Care & Billing (CC&B), was implemented in 2014 and tracked customer interactions with the District, scheduled service appointments and maintained billing history. Mr. Malone said that Oracle Utilities Analytics (OUA) is an adjacent application used to provide reporting and analysis of customer information and is part of the upgrade proposal. He said that Oracle CC&B is at the end of life and Oracle will not provide further updates to the existing software. In anticipation of the end of life on the existing version of CC&B, in April 2018, the Board approved Projects 10546 and 10547, each in the amount of \$1,424,500, for a total of \$2,849,000 to fund an initiative to upgrade CC&B to the latest version to perform a technical upgrade of CC&B with minimal change to existing business processes.

Mr. Malone said that staff issued a Request for Proposal in November 2020 to five consultants with experience supporting utilities using Oracle CC&B including Infosys, Origin Consulting, Red Clay, Tata Consulting Services (TCS) and Utility Solutions. All firms, except for TCS, submitted a proposal. Mr. Malone said that staff reviewed and ranked the proposals and selected the top two firms for interviews: Infosys and Origin Consulting. He said that based on the interviews and proposal rankings, staff believes that Origin Consulting has the best understanding of the Oracle CC&B Upgrade project and the most experienced and talented project team with the CC&B application. He said that Origin Consulting submitted an optimal and realistic project schedule, and staff believes it is the most capable of implementing a successful upgrade. He further said that as part of its proposal, Origin will also prepare IRWD to eventually move CC&B to the cloud by converting custom programming code to a new standard, cloud-ready code.

Director Swan said that this item was reviewed by the Finance and Personnel Committee on February 2, 2021, and on MOTION by Swan, seconded by LaMar, and unanimously carried by a roll call vote (5-0) Withers, McLaughlin, Swan, LaMar and Reinhart voting aye, and 0 noes, THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH ORIGIN CONSULTING IN AN AMOUNT NOT TO EXCEED \$1,200,000 FOR THE ORACLE CC&B UPGRADE PROJECT, PROJECTS 10546 AND 10547.

2021 STATE LEGISLATIVE UPDATE

Using a PowerPoint presentation, Government Relations Officer/Deputy General Counsel Compton reported on the Eviction Moratorium Extension and State Rental Assistance Program, the COVID-19 Financial Relief for Water Agencies, the Low-Income Rate Assistance Program (LIRA) & SB 222 (Dodd), SB 223 (Dodd) – Discontinuation of Residential Water Service, SB 323 (Caballero) - Water Rate Validations as sponsored by ACWA, CASA's Flushable Products Legislation, and the Regional Forest and Fire Capacity Program Funding. She further provided a brief 2021 State Regulatory update and 2021 Federal Legislative update noting that IRWD's federal advocacy efforts in 2021 continue to largely focus on seeking federal funding for the Kern Fan Groundwater Storage Project and advocating for an increased funding authorization for the federal Water Storage Program.

Following discussion, Director LaMar reported that this item was reviewed and approved by the Water Resources Policy and Communications Committee on February 4, 2021. On MOTION by LaMar, seconded by McLaughlin and unanimously carried by a roll call vote (5-0) Withers, McLaughlin, Swan, LaMar and Reinhart voting aye, and 0 noes, THE BOARD ADOPTED A "CONCERNS" POSITION ON SB 222 (DODD), AN "OPPOSE UNLESS AMENDED" POSITION ON SB 223 (DODD), A "SUPPORT" POSITION ON SB 323 (CABALLERO) ACWA'S WATER RATE VALIDATIONS PROPOSAL, A "SUPPORT" POSITION ON CASA'S FLUSHABLE PRODUCTS STATE AND FEDERAL LEGISLATION, AND A "SUPPORT" POSITION ON THE \$85 MILLION BUDGET PROPOSAL FOR THE REGIONAL FOREST AND FIRE CAPACITY PROGRAM.

GENERAL MANAGER'S REPORT

General Manager Cook reported that it has been the quietest week since last March for reporting COVID-19 activity. He said that the District has had ProCare performing on-site testing at MWRP and that all tests have come back negative, which is great news. He further said that there have been approximately 40 positive cases of District employees.

Mr. Cook said that the District is at \$1.7 million outstanding for unpaid customer billing.

Mr. Cook said that Mr. Jeff Mosher, former Executive Director of NWRI, has been selected as the new General Manager of SAWPA, and will begin within a few weeks.

Director LaMar reported on his virtual attendance at the Sites Authority Town Hall, an ACWA Board of Directors' workshop, an ACC-OC Sacramento Advocacy trip, an OCBC annual Board installation, and a WACO meeting.

Director Swan reported on his virtual attendance at a CASA conference, a MWDOC/OCWD Joint Planning Committee meeting, a Sites Authority Town Hall meeting, a Public Policy Institute of California meeting on January 26 with Mr. Leon Panetta as its speaker, a MWDOC Planning and Operations Meeting, a MWDOC Board meeting, a West Basin meeting, a Newport Chamber of Commerce meeting, a meeting with UCI's Natural Resources Defense group, and an OCBC meeting.

Director Withers reported on his virtual attendance with Director LaMar at an IRWD Form 700 refresher class with Legal Counsel Collins as speaker, an ISDOC Executive Committee meeting, a WACO monthly meeting, and several OCSD meetings.

Director Reinhart reported on his virtual attendance at an OCWD/MWDOC Joint Planning meeting, a South Orange County agency meeting, a MWDOC Planning and Operations Committee meeting, a Groundwater Banking Authority JPA Board meeting, a MWDOC Board meeting, an OCWD Board meeting, a SOCWA Board meeting, and a South County Selection Committee meeting where Mr. Dennis Erdman was recommended to serve as a MWD Director for MWDOC, and a WACO meeting.

SUMMARY:

The following is submitted for the Board's information and approval:

- A. The January 2021 Investment Summary Report. This Investment Summary Report conforms with the 2021 Investment Policy and provides sufficient liquidity to meet estimated expenditures during the next six months, as outlined in Exhibit "A";
- The Summary of Fixed and Variable Rate Debt as of January 31, 2021, as outlined B. in Exhibit "B";
- C. The Monthly Interest Rate Swap Summary as of January 31, 2021, as outlined in Exhibit "C";
- D. The January 31, 2021 Disbursement Summary of warrants 414652 through 415329, wire transfers, Workers' Compensation distributions, payroll withholding distributions, and voided checks in the total amount of \$27,315,481, as outlined in Exhibit "D";
- E. The Summary of Payroll ACH payments in the total amount of \$3,203,313, as outlined in Exhibit "E"; and
- F. The Disclosure Report of Reimbursements to Board members and staff for January 2021, detailing payments or reimbursements for individual charges of \$100 or more per transaction, as outlined in Exhibit "F".

FISCAL IMPACTS:

As of January 31, 2021, the book value of the investment portfolio was \$424,056,091, with a 0.87% rate of return and a market value of \$425,443,699. Based on IRWD's January 31, 2021 quarterly real estate investment rate of return of 10.96%, the weighted average return for the fixed income and real estate investments was 2.77%.

As of January 31, 2021, the outstanding principal amount of fixed and variable rate debt was \$646,245,000. The monthly weighted average all-in variable rate was 0.34%. Including IRWD's weighted average fixed rate bond issues of 3.69% and the previous month's negative cash accruals from fixed payer interest rate swaps, which hedge a portion of the District's variable rate debt, the total average debt rate was 2.92%.

Payroll ACH payments totaled \$3,203,313, and wire transfers, all other ACH payments, and checks issued for debt service, accounts payable, payroll, and water purchases for January totaled \$27,315,481.







TWO-YEAR JANITORIAL CONTRACT AWARD

SUMMARY:

IRWD's three-year janitorial services contract with American Building Maintenance (ABM), approved by the Board in December 2017, provided an option to IRWD for a two-year renewal of the contract with updated billing rates. Staff recommends that the Board authorize the General Manager to execute a two-year janitorial services contract with ABM in the total amount of \$580,376.

BACKGROUND:

Janitorial services are required to maintain approximately 116,500 square feet of IRWD office space, including the Sand Canyon Headquarters, Michelson Operations Center, Los Alisos Water Recycling Plant, and the Baker Water Treatment Plant. A contract for these services was awarded to ABM on December 11, 2017 and expired on December 31, 2020. The contract provides for a two-year renewal at the discretion of IRWD. Because of ABM's satisfactory performance, staff indicated to ABM an interest in exercising the renewal option, and invited the firm to submit updated rates for the next two years.

Based on the rate proposal received from ABM, the first year of the two-year contract for janitorial services would be \$280,375 and the second year would be \$300,001 – increases of approximately 7.0% each year. The increases are primarily due to escalating labor costs tied to the California minimum wage. With increased competition for janitorial services due to COVID-19, staff considers this proposal to be reasonable and competitive. Details of ABM's rate proposal are provided as "Exhibit A".

FISCAL IMPACTS:

Sufficient funds for the first six months of the contract are included in the approved Fiscal Year 2020-21 Operating Budget. Funds for the remainder of the contract will be submitted in the FY 2021-22 Operating Budget process.

ENVIRONMENTAL COMPLIANCE:

This item is not a project as defined in the California Environmental Quality Act (CEQA), Code of Regulations, Title 14, Chapter 3, Section 15378.

COMMITTEE STATUS:

Contract awards are not submitted for Committee review.

MICHELSON WATER RECYCLING PLANT BIOSOLIDS AND ENERGY RECOVERY FACILITIES BUDGET INCREASE

SUMMARY:

Construction of the Michelson Water Recycling Plant (MWRP) Biosolids and Energy Recovery Facilities is complete, and the final phase of startup and commissioning activities is underway. A budget increase is required to support project close-out and the remaining commissioning activities. Staff recommends the Board Authorize a budget increase in the amount of \$27,000,000, from \$238,542,100 to \$265,542,100 for the MWRP Biosolids and Energy Recovery Facilities Project.

BACKGROUND:

Construction of the project was awarded to Filanc-Balfour Beatty (FBB) in March 2013. The project includes biosolids digestion, dewatering, energy production, and on-site sludge drying facilities. These facilities were constructed on the land north of IRWD's existing Operations Center, maintenance shops, water quality laboratory, and warehouse. All construction activities are complete, and FBB has demobilized from the site. FBB continues to maintain a small field support team that is coordinating the remaining startup and commissioning activities associated with the microturbine energy recovery facilities and the heat dryer system.

FISCAL IMPACTS:

The MWRP Biosolids and Energy Recovery Facilities, Project 04286, is included in the FY 2020-21 Capital Budget. With the extension of the project beyond the estimated completion date, a budget increase is required to fund project close-out activities, startup and commissioning activities for staff and its construction phase consultants, staff training activities, and ongoing legal expenses. Staff requests a budget increase as summarized in the table below:

MITCHELL EAST HABITAT MITIGATION PROPERTY PURCHASE

SUMMARY:

IRWD is pursuing the purchase of properties to provide required habitat mitigation for future District capital projects. On June 1, 2020, IRWD executed a Real Property Purchase Agreement for vacant land known as the "Mitchell East" Property, comprised of approximately 39.8 acres located in the Trabuco Canyon area of Orange County. The Purchase Agreement allowed staff to conduct tests, inspections, and other such due diligence activities necessary prior to the acquisition of the Property. This report provides the findings of the due diligence work. Staff recommends that the Board:

- Find that all matters currently identified with regard to the condition of title, physical condition and suitability of the Property for the uses contemplated are acceptable contingent upon all of the property being removed that is not fixed to the land;
- Approve the addition of \$990,000 to the FY 2020-21 Capital Budget for "Mitigation Land", Project No. 11093;
- Determine the acquisition of the Property is exempt from CEQA, approve the project and authorize staff to post and file the Notice of Exemption in Orange County; and,
- Authorize the General Manager, Treasurer, and each other officer of the District, each
 acting singly, to execute and deliver any and all documents, assignments, certificates,
 instructions and instruments necessary or proper for carrying out and closing the real
 estate purchase transaction for the acquisition of the Property.

BACKGROUND:

IRWD is pursuing the purchase of properties in Orange County to provide required habitat mitigation for the District's various planned capital projects. The Mitchell East property is located in the Trabuco Canyon area in an unincorporated portion of eastern Orange County.

Following approval by the Board on May 26, 2020, the District entered into escrow for the purchase of the Mitchell East Property for \$950,000 and began due diligence work related to suitability of the property for habitat mitigation. Per the terms of the Property Acquisition Agreement, the District has deposited \$65,000 in escrow which will be applied to the purchase price. Following is an overview of the Mitchell East Property, due diligence work conducted on the Property, results of an appraisal of market value, and a recommendation for the purchase of the Property.

Property Overview:

The Mitchell East Property is located in the Trabuco Canyon area in an unincorporated area of eastern Orange County and consists of approximately 39.8 acres owned by the

Parker family. The property is located in the County's Foothill / Trabuco Specific Plan Area with the Trabuco Creek crossing the southern portion of the property. A location map is included as Exhibit "A", showing the location of the property.

Due Diligence Investigations:

The Purchase Agreement provides for a six-month due diligence period during which staff conducted studies, tests and inspections deemed necessary prior to the acquisition of the Property. Fuscoe Engineering was retained to perform due diligence investigations on the Property. These investigations for the Property have been completed and include: an American Land Title Association survey, a Preliminary Title Report review, an Environmental Phase 1 site assessment, examination of surface soils, flood and seismic hazards, and a review of the general plan for the area and zoning designations. Additionally, consultants at Environmental Science Associates (ESA) evaluated the habitat quality at the property.

Following is a summary of the findings of the due diligence work:

Preliminary Title Report Review:

Staff found no items of record to contest in the review of the Preliminary Title Report.

ALTA Survey:

Fuscoe Engineering prepared an American Land Title Association (ALTA) survey of the Property that documents all easements. The County of Orange has an easement over the property referred to as "Trabuco Creek Road". Property is subject to the Foothill/ Trabuco Specific Plan. Per the Specific Plan, the property has two zonings, Open Space Conservation and Trabuco Canyon Residential.

Phase 1 Environmental Site Assessment:

A Phase 1 Environmental Site Assessment was performed by Fuscoe's subcontractor Group Delta. The Phase 1 evaluation identified an existing well inside of a shed and a water tank in the middle of the property along with remnants of a demolished building. The sellers did not have any information about the well construction. At the time of the assessment, an abandoned trailer was onsite with propane tank and storage container, and these have since been removed from the property with some household debris remaining. There is a transformer observed on a power pole, as well as a downed electrical pole near the center of the property. No spills or leaks or recognized environmental conditions were found. Past uses include orange and avocado orchards with only few trees and some ornamental plants remaining. Group Delta recommended, depending on the planned use, abandoning the existing well and removing the power poles.

Groundwater, Soils and Flood and Seismic Hazards:

The site is located within the San Juan Valley groundwater basin and is part of the San Juan-Mission Viejo-Upper Trabuco watershed. Groundwater on the site has been historically used for

irrigation of past agricultural orchards. Groundwater elevation in the area is approximately 1,100 feet above mean seal level. The Property is at an elevation of approximately 1,197 feet. Groundwater flow is to the south. The predominant soils on the property are gravelly silt loam, sandy loam and sand.

The southeast half of the property is located within a flood zone influenced by the Trabuco Creek. The areas of potential restoration opportunity are not within this zone. There are no seismic hazards identified.

Habitat Quality:

Consultants at ESA performed a site inspection and prepared a vegetation map of the property. Of the approximately 40 acres, 26 acres are considered high value coastal sage scrub, 4.3 acres are moderate value habitat with 3.2 acres of coast live oak woodland. There are approximately two acres of disturbed area where previous farming occurred which has potential for restoration. Staff did procure a water sample from the existing onsite well, which was tested. The water quality is sufficient for irrigation with low total dissolved solids. If needed, the well could be equipped to provide irrigation for habitat restoration on the property.

The property is located within Orange County Transportation Authority's Conservation Assessment priority conservation areas, possessing good potential biological value for gnat catcher, orangethroat whiptail, arroyo toad and coastal cactus wren. The property contains oak woodlands, and the southern portion is within a wildlife corridor of the Foothill / Trabuco Specific Plan area and within the critical habitat area for the arroyo toad and the coastal California gnatcatcher. Although no gnatcatchers were observed on the property at the time of ESA's site visit, it does contain suitable habitat with the potential for occurrence of gnatcatcher. Acquisition of the property can enable this corridor segment of the Trabuco Canyon area to be preserved as permanent open space to enhance wildlife connectivity.

Findings of Real Property Appraisal:

The District retained real property appraiser Cortland Valuation Group, Inc., to provide a current market valuation of the Mitchell East Property. Based on the appraisal report, the market value for the Property as of November 12, 2020 is \$955,000. The appraisal report noted that the zoning for the property could allow for up to four residential units on 16 acres of the parcel, with the balance of the property described as open space due to terrain characteristics. A lack of sufficient utilities and infrastructure make the possibility of any residential development of the site improbable in the foreseeable future. The report also noted that, "There is adequate demand for this type of land from private conservation companies and public agencies resulting in added value to the land."

FISCAL IMPACTS:

The total purchase cost for the Property is \$950,000, plus approximately \$40,000 for closing costs, including \$15,000 to extend the due diligence period to February 28, 2021.

The cost for the due diligence work including the Fuscoe evaluation, staff and legal time was approximately \$40,000. Staff requests the addition of the project "Mitigation Land", Project No. 11093 to the FY 2020-21 Capital Budget in the amount of \$990,000. Costs associated with the mitigation land procured and held under this budget item will be re-allocated to individual future capital projects once the mitigation requirements have been determined.

ENVIRONMENTAL COMPLIANCE:

Any new lands purchased for mitigation purposes would be subject to compliance with the California Environmental Quality Act of 1970 (as amended), codified at California Public Resources Code Sections 21000 et. seq., and the State CEQA Guidelines in the Code of Regulations, Title 14, Division 6, Chapter 3. Pursuant to direction by the Board, staff will file a Notice of Exemption for the purchase of the Mitchell East Property within the County of Orange. The Notice of Exemption states that the District is not presently contemplating changes in the existing use of the land and therefore no environmental impacts associated with the Property acquisition are expected. The Notice of Exemption states that the District specifically conditions any proposed future change in use of the Property on subsequent CEQA compliance actions.

COMMITTEE STATUS:

This item was reviewed by the Engineering & Operations Committee on February 14, 2020.

RECOMMENDATION:

THAT THE BOARD FIND THAT ALL MATTERS CURRENTLY IDENTIFIED WITH REGARD TO THE CONDITION OF TITLE, PHYSICAL CONDITION AND SUITABILITY OF THE MITCHELL EASE PROPERTY FOR THE USES CONTEMPLATED ARE ACCEPTABLE; APPROVE THE ADDITION OF THE PROJECT "MITIGATION LAND", PROJECT NUMBER 11093 TO THE FY 2020-21 CAPITAL BUDGET IN THE AMOUNT OF \$990,000; FIND THAT THE PROPERTY ACQUISITION IS EXEMPT FROM CEQA; APPROVE THE PROJECT AND AUTHORIZE STAFF TO POST AND FILE THE NOTICES OF EXEMPTION IN ORANGE COUNTY; AND AUTHORIZE THE GENERAL MANAGER, TREASURER AND EACH OTHER OFFICER OF THE DISTRICT, EACH ACTING SINGLY, TO EXECUTE AND DELIVER ANY AND ALL DOCUMENTS, ASSIGNMENTS, CERTIFICATES, INSTRUCTIONS AND INSTRUMENTS NECESSARY OR PROPER FOR CARRYING OUT AND CLOSING THE REAL ESTATE PURCHASE TRANSACTION FOR THE ACQUISITION OF THE PROPERTY.
