Description of Nature, Purpose and Beneficiaries of Project:

The existing Portola Hills Sewage Lift Station (PHSLS) is located on the southwest corner of the Glenn Ranch Road and Saddleback Ranch Road intersection. It was constructed in 1989 as a temporary facility to serve the Portola Hills area because the Glenn Ranch Road did not exist west of Saddleback Ranch Road. The PHSLS is the first of several lift stations used to lift the wastewater to Santa Margarita Water District's Chiquita Wastewater Treatment Plant. This project will abandon the existing PHSLS and redirect wastewater to the Michelson Water Recycling Plant through a new gravity system within Glenn Ranch Road. The proposed 4,000 ft. Glenn Ranch Road sewer will be located in the existing public right of way and connect to the existing Bake Parkway trunk sewer and the San Diego Creek Interceptor.




Figure 1 Glenn Ranch Road Sewer and Portola Hills Sewage Lift Station Abandonment
