Description of Nature, Purpose and Beneficiaries of Project:

Irvine Ranch Water District (IRWD) owns and operates the San Joaquin Marsh (Marsh). The Marsh is a natural water treatment system facility, located in Irvine between Michelson Drive, Carlson Drive, Campus Drive, and San Diego Creek. The Marsh is composed of 11 interconnected ponds that provide freshwater wetland and water quality treatment functions including nutrient removal. Water is pumped to the Marsh from San Diego Creek Channel via the San Diego Creek Pump Station (SDCPS).

This project will construct miscellaneous improvements in the Marsh to improve operations at the Marsh and enhance water circulation within the Marsh. The improvements include: the replacement of the pumps in the SDCPS with variable speed pumps; the replacement of the SDCPS motor control center; the installation of a new automated strainer at the Marsh Pump Station; the installation of flow monitoring equipment to meter flows in the upper Carlson Marsh; and improvements to contain flood irrigation waters within the Marsh. 
