Description of Nature, Purpose and Beneficiaries of Project:

Irvine Ranch Water District (IRWD) owns and maintains the Michelson Sewer Force Main, a 3,800 foot, 12-inch ductile iron force main, located in Michelson Drive between Jamboree Road and Riparian View in Irvine, CA. With the use of valves, the force main conveys sewage from the Michelson Sewage Lift Station to either Orange County Sanitation District's (OCSD) trunk sewer in Michelson Drive west of Jamboree Road or to IRWD's Michelson Water Recycling Plant (MWRP). Recent inspections of the force main have determined that portions of the sewer pipeline will require rehabilitation.


This project will install cast-in-place pipe lining to rehabilitate both sewer force main segments. The rehabilitation of the two force main segments will be performed sequentially and separately (i.e. one direction at a time), to allow the diversion of flow to OCSD while work is being performed on the segment to MWRP and vice-versa.
