Description of Nature, Purpose and Beneficiaries of Project:

Irvine Ranch Water District's (IRWD) San Joaquin Marsh is a more than 300 acres of coastal freshwater wetlands which provides habitat for more than 200 bird species. Located off Riparian View and adjacent to IRWD's Michelson Water Recycling Plant, the Marsh Campus is home to educational facilities, the Sea and Sage Audubon Society and an IRWD caretaker residence. The Marsh has a sewer lift station which provides sewer service to these facilities. Recent inspections of the lift station indicated that rehabilitation to portions of the lift station were necessary.

This project will rehabilitate the San Joaquin Marsh Campus Sewer Lift Station. Improvements will include installing a pump system, installing a polyurethane coating, replacement of discharge piping inside the lift station vault, installing valves, a sewer manhole, and miscellaneous electrical improvements. A temporary sewer bypass system will be installed prior to construction so that sewer services to the Marsh Campus buildings remain operational during construction.
