Description of Nature, Purpose and Beneficiaries of Project:

Irvine Ranch Water District (IRWD) owns, operates and maintains several disinfection facilities used to disinfect water in its service area. Among these facilities is the Primary Disinfection Facility (PDF), located off South Halladay Street in Santa Ana. PDF uses a chlorine gas system to disinfect the water to drinking water standards. Due to increased safety and operational improvements, as well as ongoing Cal-ARP RMP and Cal/OSHA regulatory requirements, IRWD will replace the chlorine gas system at PDF. This project follows similar conversion projects completed by IRWD at several of its other disinfection facilities.

This project involves the removal of the existing chlorine gas system and related appurtenances, and the installation of liquid sodium hypochlorite storage and feed facilities. In addition to the installation of sodium hypochlorite storage and chemical feed system, the project also includes new valves and minor modifications to the existing facility. The project also includes the addition of a carbon dioxide storage and feed system.
