Description of Nature, Purpose and Beneficiaries of Project:

Irvine Ranch Water District (IRWD) owns and operates a 15-million-gallon, welded steel domestic water storage reservoir, located on Sand Canyon Avenue near Elysian, in Irvine, CA. The reservoir was originally constructed in 1983, and the interior coating was subsequently replaced in 1995. Recent inspections of the reservoir indicated that the interior coating and other internal components have reached the end of their useful life and require rehabilitation and/or replacement.

This project involves the removal and replacement of the reservoir's existing interior coating and minor repairs to portions of the existing exterior coating. The project will also replace existing roof hatches, install a new roof hatch, replace the roof vent, install new guard rail, repair the existing cathodic protection system, and repair interior reservoir structural steel members. The existing onsite pumps, motors, piping, and surge tank associated with the adjacent Zone 1 to 3 pump station will also be coated.

Reasons why project is exempt:

The interior of the existing Zone 1 Reservoir will be repaired by removing corrosion from the tank's rafters, roof plates and structural connections. After removing the corrosion, the entire interior of the reservoir will be re-coated. In addition to the coating, some components of the reservoir will be repaired and/or replaced.

State Guideline §15301 provides exemption for the operation, repair, maintenance, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. State Guideline §15302 provides exemption for replacement of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced including but not limited to: (b) replacement of a commercial structure with a new structure of substantially the same size, purpose and capacity; and (c) replacement of or reconstruction of existing utility systems and/or facilities involving negligible or no expansion of capacity.

Submission of this form is optional. Local agencies may file this form with the county clerk pursuant to Public Resources Code Section 21152(b). The filing of the notice starts a 35-day statute of limitations on court challenges to the approval of the project under Public Resources Code Section 21167(d). 
